#### **Editorial Policy**

- To focus on publishing quality sports law or sports administration material dealing with current topics of interest to professionals, academics and sports administrators.
- Articles to be of a high standard demonstrating thought and intellectual rigor in the manner in which current issues are addressed by the author.
- Articles should range in length between 5,000 and 12,000 words.
- Articles must conform to the style guide prescribed by *The Australian Guide to Legal Citation*, Second Edition, published by the Melbourne University Law Review Association Inc., Melbourne, Australia (<http://mulr.law.unimelb.edu.au/>)

#### **Submission of Articles**

- Articles should be submitted by 31 May of each year for consideration for publication.
- The article will be refereed by two suitable persons, determined by the Editor, in consultation with the ANZSLA Journal Editorial Committee.
- The Author by submitting the article agrees to license and authorise ANZSLA to publish the material and also acknowledges that the article, is his, her or their original work and has not been published elsewhere previously.

To ensure that we correctly acknowledge you as the author of your article, please provide the following information at the end of your article: full name, firm or organisation, position/title. Please also include a brief description of your area(s) of relevant expertise.

## **Formatting**

- MS Word format
- Margins are to be set as follows:
  - Top and Bottom Margins: Half an Inch
  - Side Margins: One Inch
- Please do not use automatic formatting
- Font: Times New Roman, 10 point
- No indents or other formatting
- Bolding, underlining and italic is acceptable
- Single space format
- Simple bullets and numbers are acceptable
- Please do not include any information identifying the author in the article
- Footnotes are required. No End-Notes.

## **Abstract**

All articles submitted for publication must be accompanied by an abstract which summarises the main theme and nature of each article.

For the *Australian and New Zealand Sports Law Journal*, abstracts should be no longer than 100 words.
